

Terms and Conditions

I understand that Blood Hound, LLC is an Equal Opportunity Employer. I understand that the Company's policy is not to discriminate against any applicant or employee based on race, color, national origin, religion, sex, age, disability, genetic information, veteran status or any other basis protected by applicable federal, state or local law. I understand that Blood Hound, LLC also prohibits harassment of applicants and employees based on any of these protected categories. I understand that Blood Hound, LLC will comply with its legal obligation to provide reasonable accommodation to qualified individuals with disabilities.

I understand that smoking is prohibited in all indoor areas of Blood Hound, LLC, unless a particular location has established a designated smoking area in accordance with applicable state and local law.

I understand that a resume may be provided but does not substitute for completion of this portion of the application process.

I certify that all of the information furnished during the application process is TRUE, CORRECT and COMPLETE to the best of my knowledge. I agree to submit to legally permissible drug testing upon an offer of employment from Blood Hound, LLC and prior to starting work. I agree that any offer of employment is contingent upon my receiving a negative test result.

I understand and expressly agree that if Blood Hound, LLC employs me, the Company may investigate storage and work areas provided for me (locker, desk, vehicle, etc.) without giving me prior notice.

I understand that, if Blood Hound, LLC offers me employment, I may be required to sign a confidentiality agreement as a condition of employment.

I understand that Blood Hound, LLC may share any information provided or collected during the application process with other Blood Hound, LLC employees for employment and administrative purposes, and I consent to such transfer.

I certify that I am not bound by any employment contract or non-competition agreement that would be breached by any employment that might be offered to me by Blood Hound, LLC, nor am I in possession of, nor will I at any time reveal to Blood Hound, LLC, under any circumstances, any proprietary or confidential information that is the subject of any contract, non-disclosure agreement or prior work relationship involving any other person or entity.

I understand that, according to federal law, all individuals who are hired must, as a condition of employment, produce certain documentation to verify their identity and United States citizen status or, if aliens, their legal authorization to work in the United States. As a consequence, I understand that any offer of employment to me by Blood Hound, LLC is contingent upon my ability to

I understand that the application process is not, and is not intended to be, a contract of employment. I understand that no representative of Blood Hound, LLC, other than an officer, has the authority to enter into any agreement for employment for any specific period of time or to make any agreement contrary to the foregoing and that any such agreement must be in writing to be binding on Blood Hound, LLC. I understand that Blood Hound, LLC will not administer or require me to submit to a lie detector test as a condition of prospective employment.
